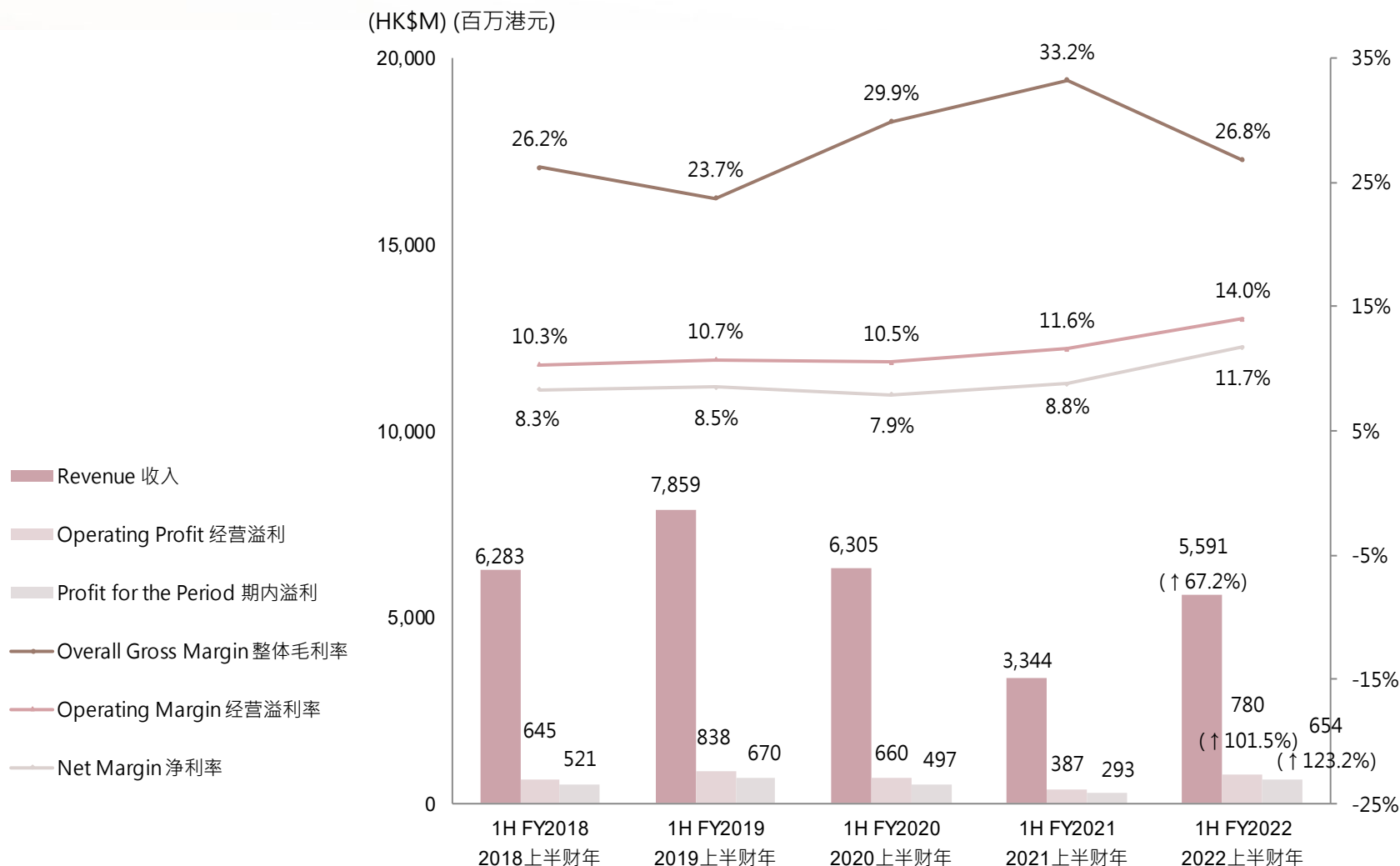

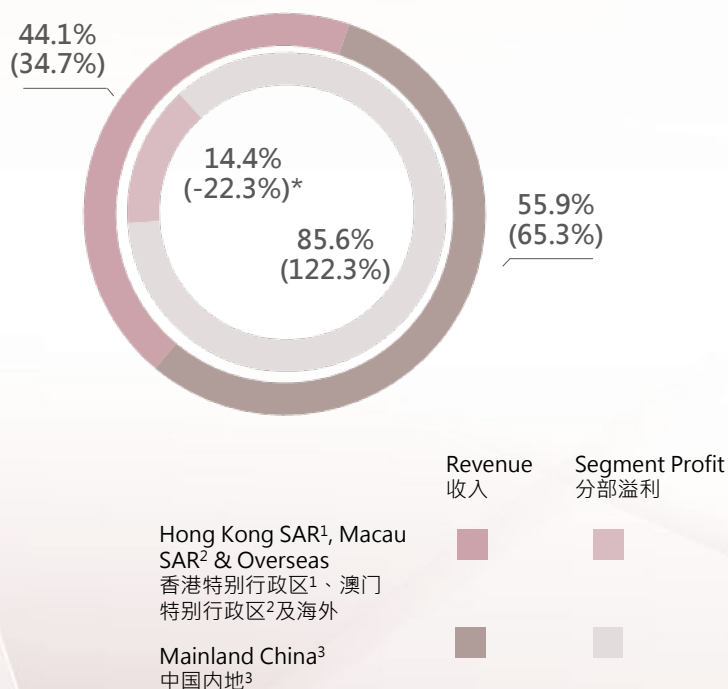

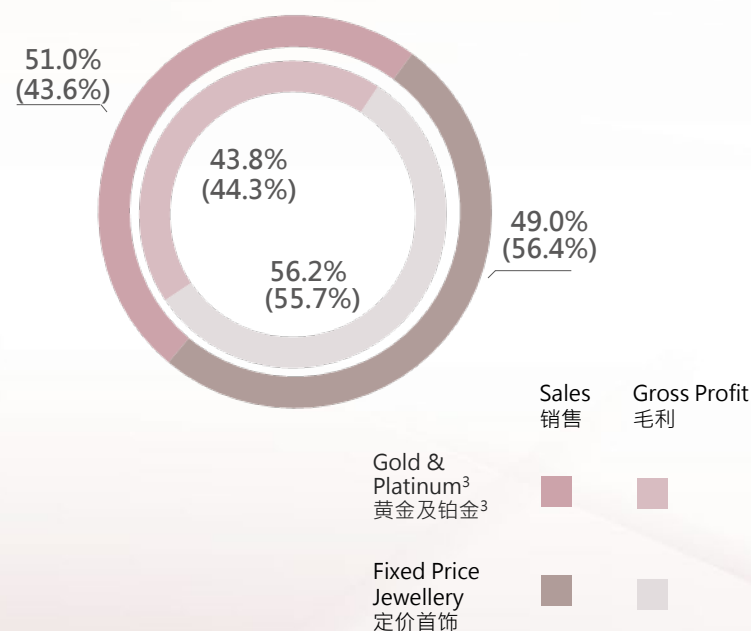

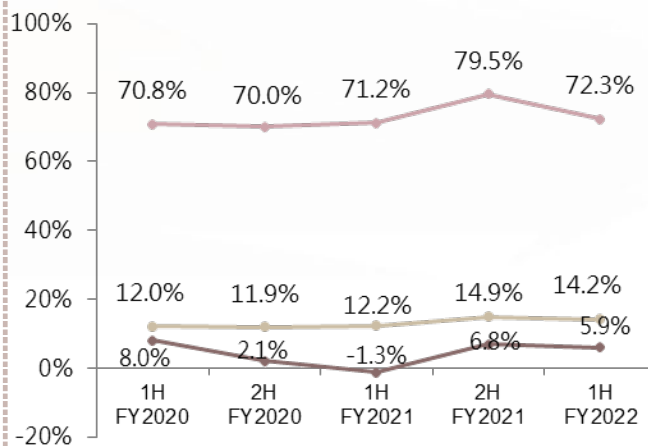

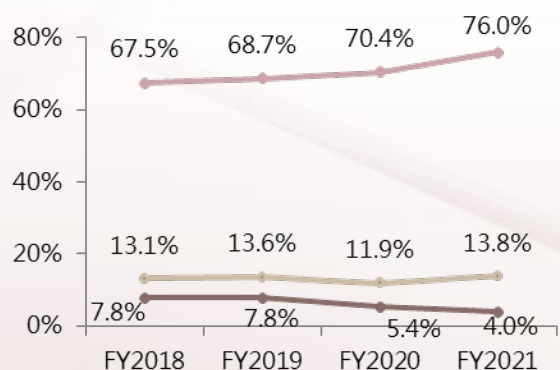


Segment Profit Margin by Business

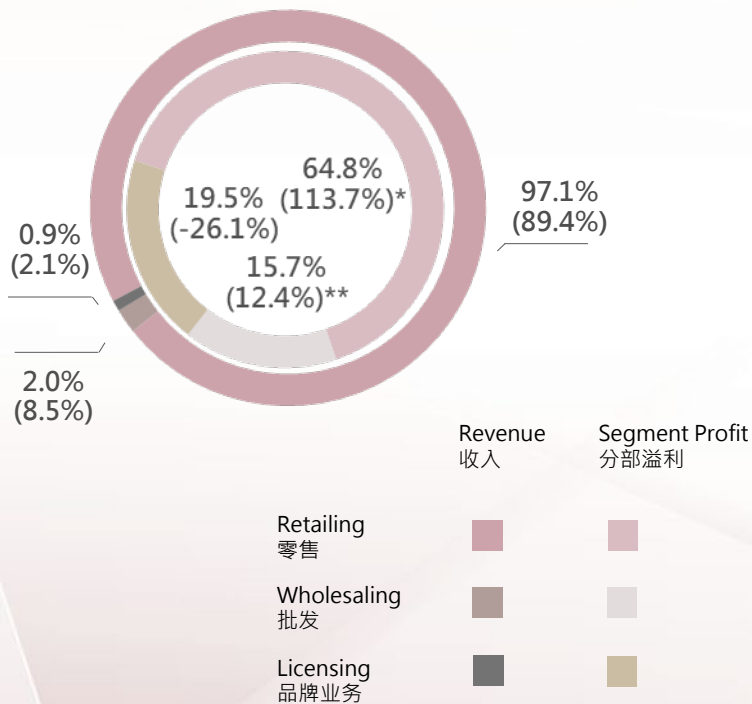

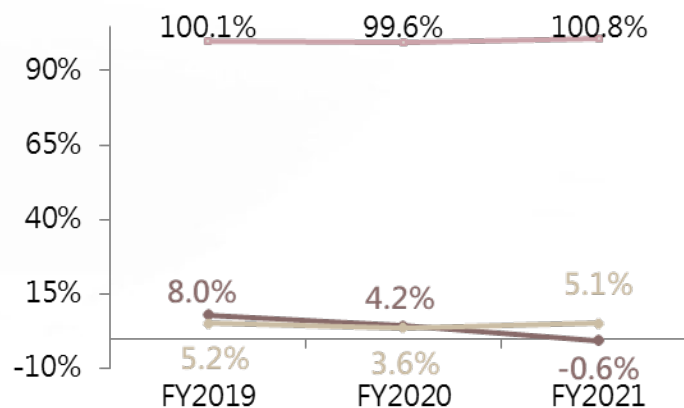

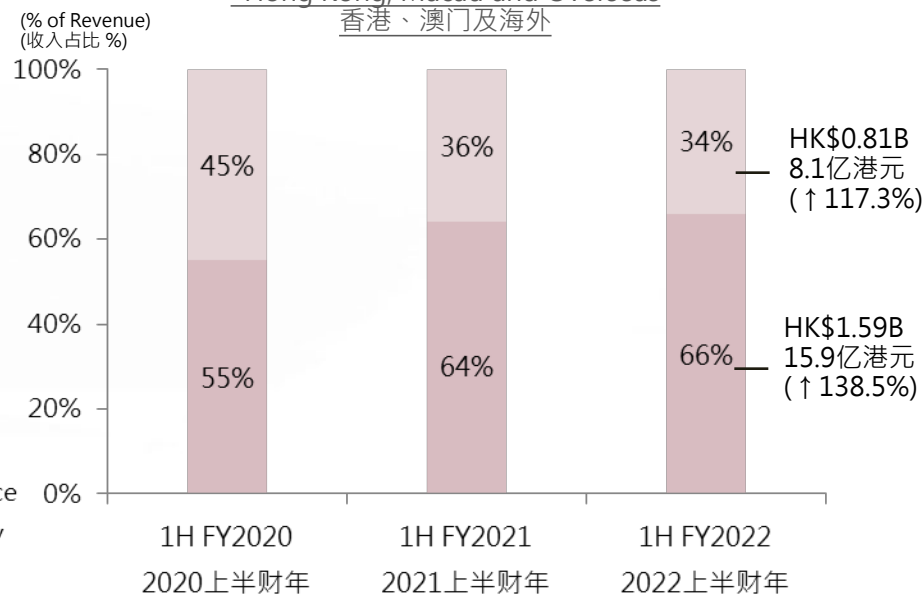

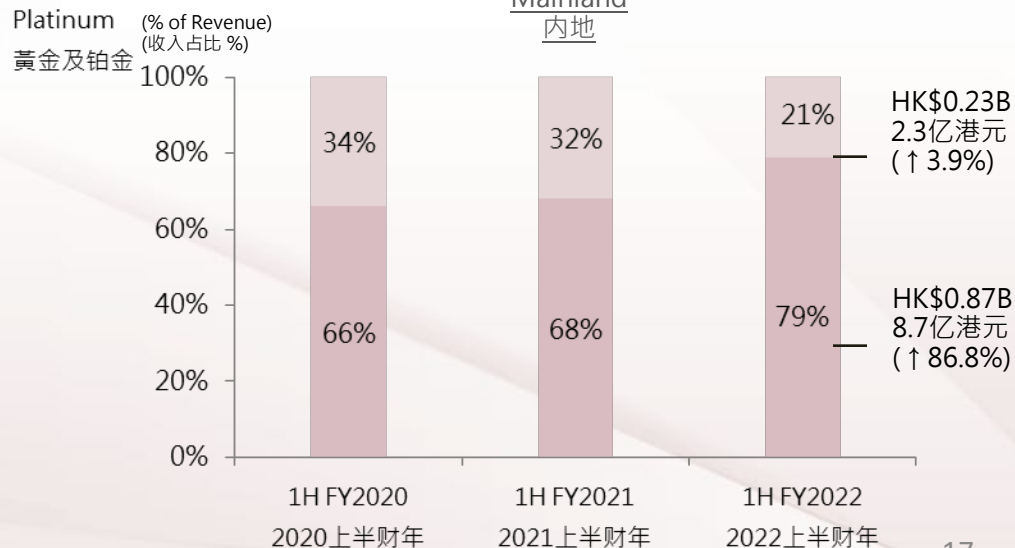


Retail Revenue by Product

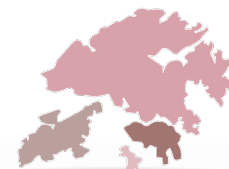

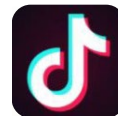

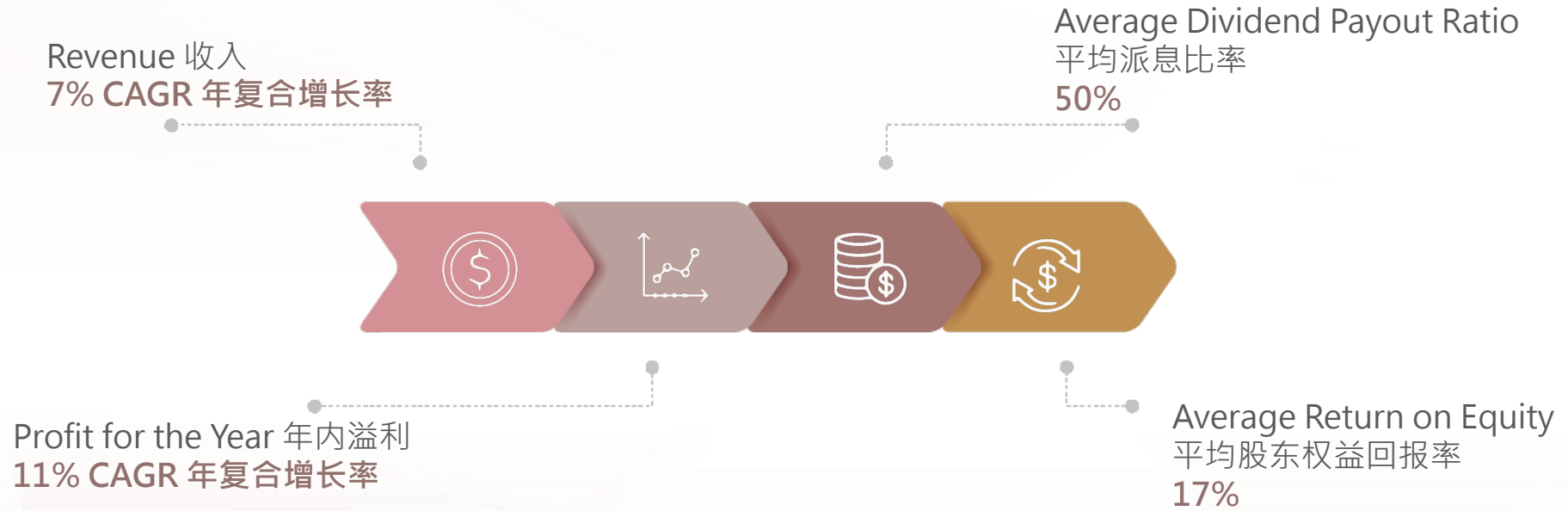

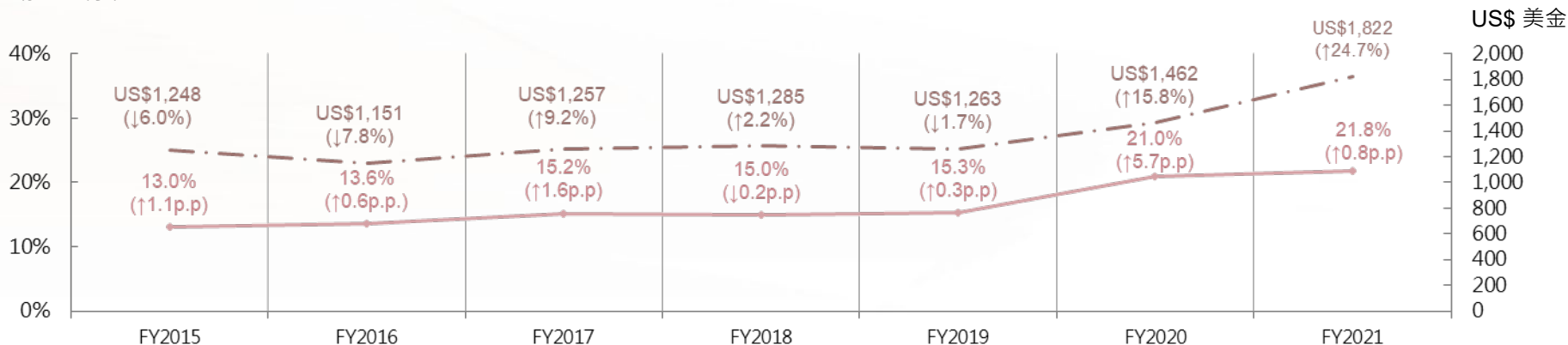
AVERAGE GOLD PRICE CHANGES & GP% OF GOLD

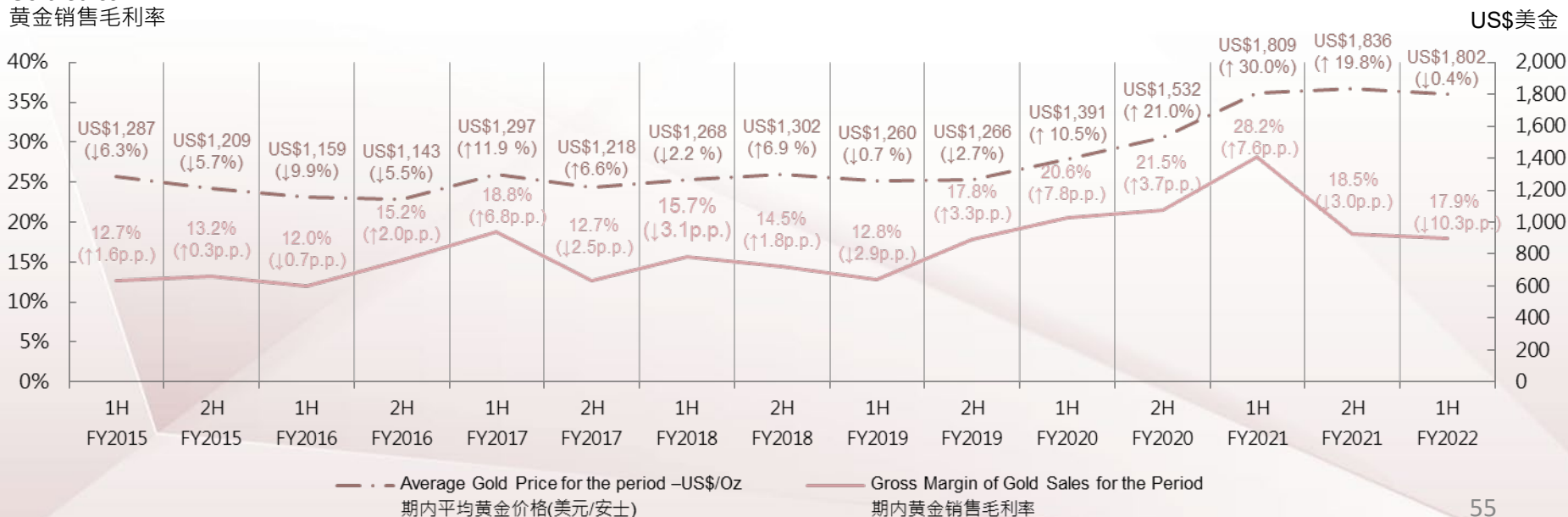
Gross Margin of Gold Sales

1H&2H 上半年及下半年

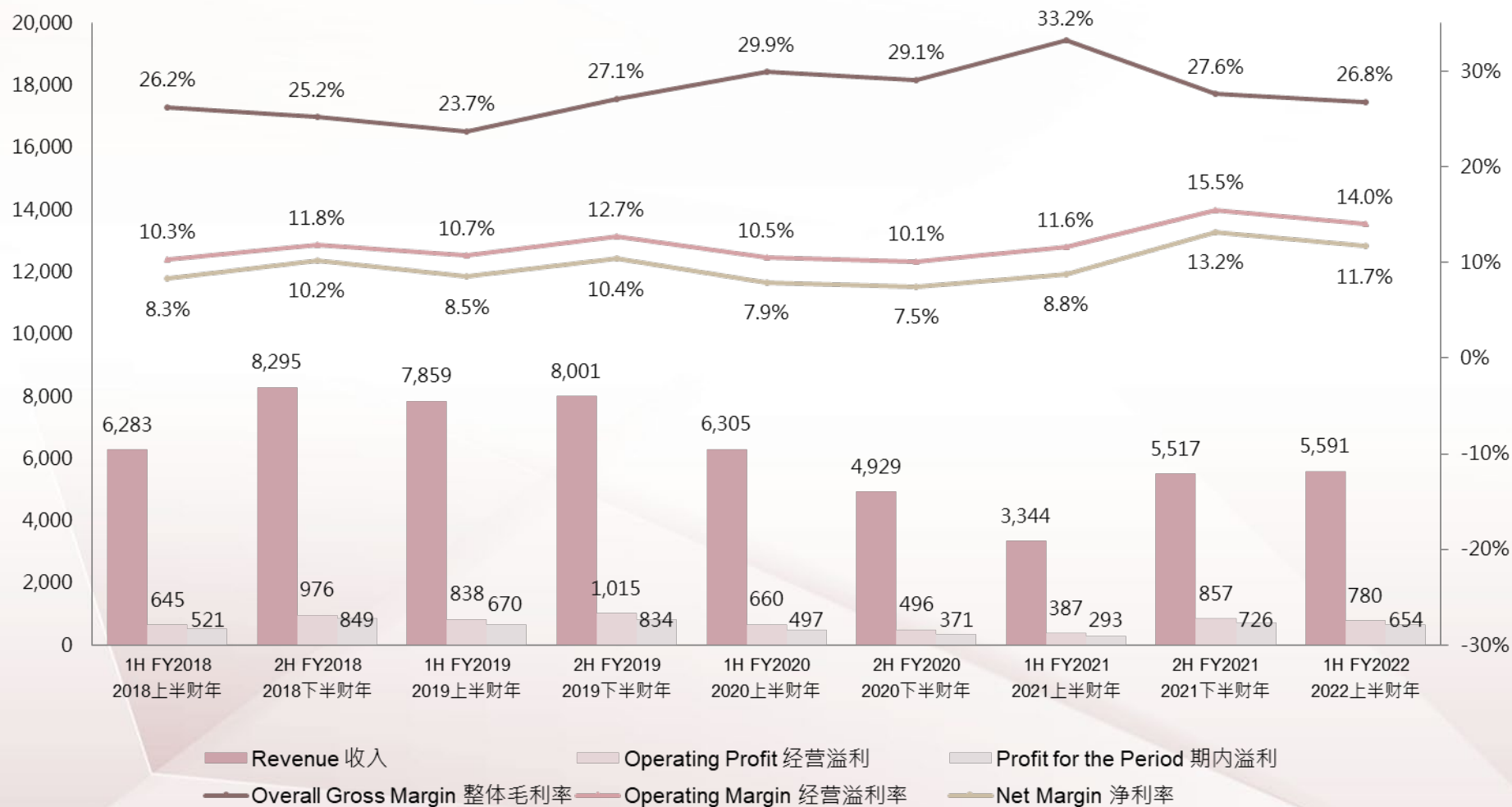
